

Cash handouts for low-income households (70,000 yen per household)



※ Application is required in order to receive the handout.

- As a new form of financial support for residential tax-exempted households, Ichikawa City is going to provide “cash handouts for low-income households (70,000 yen per household)” using contingency fund for tackling soaring energy and food prices.
- **Application is required** in order to receive the handout.

Amount and time period of handouts

70,000 yen per household

Application deadline: **Tuesday, April 30, 2024**
(post stamps until April 30 are valid)



It takes **about a month to process** your application.

Eligible households

Applicant households must meet both requirements shown in 1 and 2.

1. A household that was registered in Ichikawa City as of December 1, 2023.
2. Residential tax in fiscal 2023 of all members in the households must be exempted.

※ However, households consisting of dependents of a person whose residential tax for fiscal 2023 is imposed are excluded.

(Even if a household received a 30,000-yen cash handout targeting on low-income households in Ichikawa City, a household like the following cases may not be eligible this time.)

e.g.

- * A person who was a student and a dependent of his parent in fiscal 2022, but he is now employed and is living on his own since fiscal 2023.
- * A tax-exempted person whose sole income is a pension and who is a dependent of his or her child living in another household.
- * A mother and her child are living alone as a tax-exempted household, but they are dependents of the father who is working and living afar temporarily.
- * A student who is currently living alone in order to go to university, and he is a dependent of his parent.

How to get the cash handouts

Ichikawa City will send out documents to eligible households starting from late January to early February. When the documents reach you, please apply using one of the following methods.

① For persons who received a **“Confirmation Document”**

Please **send it back** to Ichikawa City Hall after confirming the contents written in the pledge/agreement, and filling out the required fields.

Eligible households that the documents will be sent out eligibility will be determined according to the residential taxation in fiscal 2023.

② For persons who received documents **other than the one indicated in ①**

Application is necessary in order to receive the cash handouts.

Eligible households that the documents will be sent out households in which the residential taxation in fiscal 2023 of all members cannot be confirmed.

- In case of sending application form by post, please call the call center. An application form will be sent to you.

③ You think you are eligible, but you **haven't received the documents**.
