Ichikawa City provides assistance with school expenses (e.g. a part of school supply cost) to households with children receiving compulsory education (public elementary schools, junior high schools and compulsory schools who are experiencing financial difficulties.

If you wish to receive this assistance, please apply to the school.
(within the condition of income caps)

Households currently receiving this assistance also need to submit a new application form each fiscal year.

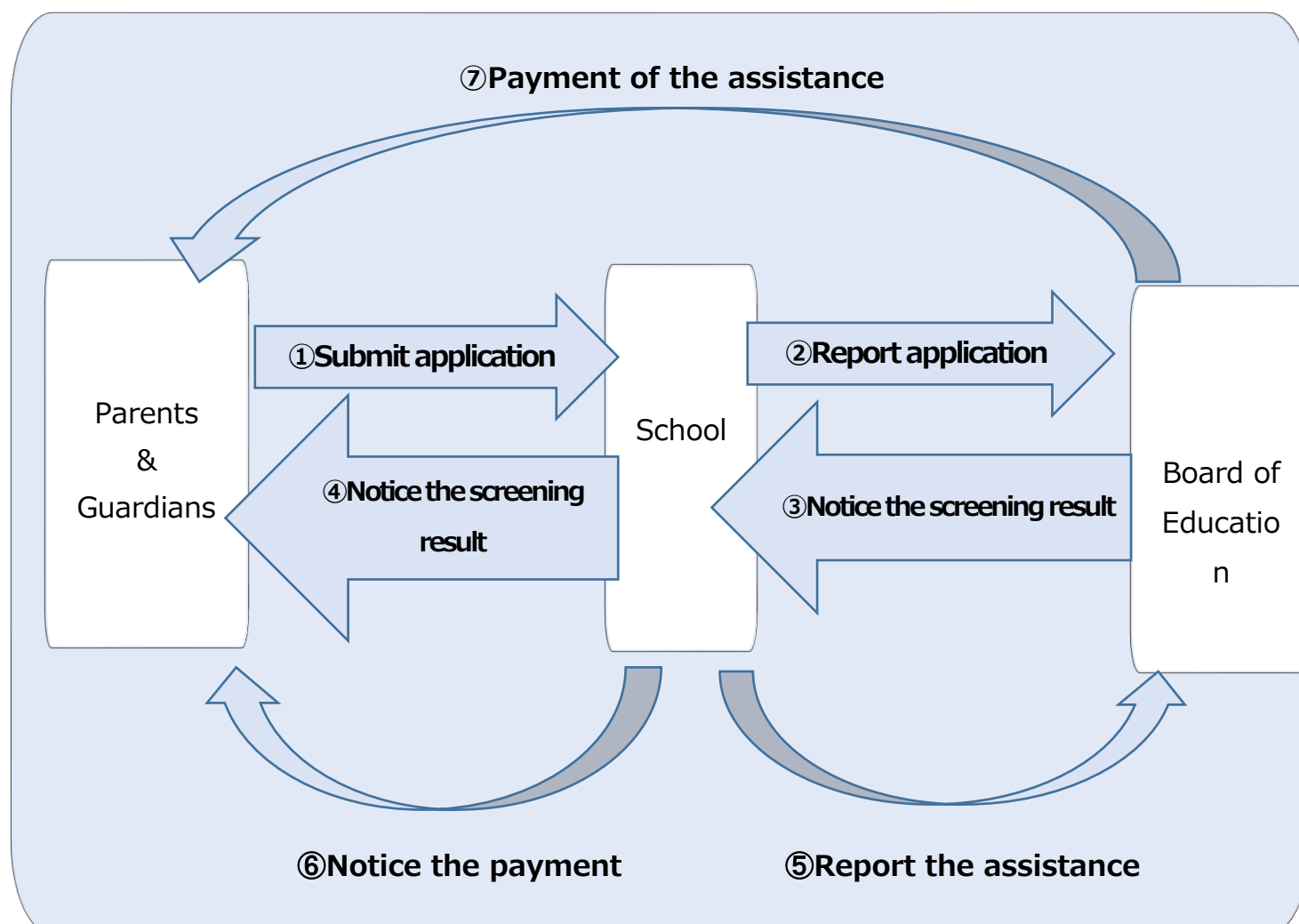
1 Eligible households: The residents of Ichikawa City who are applicable to either (1) or (2)

- (1) Who are in receipt of public assistance(Seikatsu Hogo)
- (2) Who are not in receipt of public assistance(Seikatsu Hogo) but experiencing financial difficulties
e.g. exempt from municipal tax payment, receiving child rearing allowance(Jido Fuyo Teate), low income level

- ※ Amounts in the above table indicate only guidelines. The actual limit amount can vary according to the composition of the households. For more detail, please ask Division of School Attendance
- ※ For salaried worker, "income"(revenue - necessary expenses) means "amount after deduction from salary income" of withholding record. For person who files business tax, "income" means "total amount of income" on final return.
- ※ The income limit amount is the total income of all members living together. Persons who live together are considered members of the household even if they are not registered on the same

2 How to apply ※An application form is required for each applicant student.

(1) Fill out an application form

Application forms are prepared at office rooms of schools. Please refer to an example and fill out an application form.

- ◇ Please submit the application to an office of the school.

4 Application deadline

◇ **Wednesday, April 30th,2025**

(The application submitted until the deadline will be certified as of April 1st.)

※**You can apply even after the deadline.**

When the application was submitted until the 15th day of the month, the assistance will be paid from the 1st day of the applied month.

5 Notice of the result of the application (All applicants will be noticed)

The result of the application will be noticed through the school. The applicants who applied until Wednesday, April 30th,2025 will be noticed around early July.

The applicants who applied after the deadline will be noticed about one to two months later.

※If there are mistakes in your application form or attached documents, notice of the approval might be delayed.

※**1** Financial Assistance for School Expenses is a program to provide above assistances to whom be certified. The assistances will be paid at the above mentioned date to designated bank account of the guardian.

Regarding the expenses to be paid to the school, please follow the instruction of the school.

※**2** The household who was certified during the fiscal year will receive the amount according to the certified period. Which will be less than the full amount shown in the column above. There will be no compensation for the expenses paid by the applicant before the certification.

※**3** "School supplies for new students" are only applicable for 1st grade of elementary school(and Compulsory School) and 1st grade of Junior High School(and 7th grade of Compulsory School) who are certified in April. The households who already received the assistance in March are not applicable.

※**4** "Medical expenses" will be paid when students have suffered from diseases specified in School Hygiene and Safety Act and instructed by the school to be treated. (Applicable diseases: tooth decay, trachoma, conjunctivitis, inflammation of the middle ear, chronic sinusitis, adenoids, trichophytosis, itch, impetigo, parasitic disease)

Assistance amount will be a medical fee amount (The self-pay ratio of the medical expenses covered by national health insurance).

A notification and an application form of Ichikawa City's medical expenses assistance will be handed out to an eligible student from the school. Then fill out the application form and submit it with prescribed attached documents to Board of Education. A "medical ticket" will be delivered to the student, with which the applicable medical treatment will be free of charge.
